JANCO Classification System

Introduction

The JANCO classification system is the South Australian adaptation of the Australian Bureau of Statistics' offence classification system ANCO (Australian National Classification of Offences, 1985, Catalogue No. 1234.0). JANCO adheres to the most detailed level of ANCO and extends this to even more detailed levels to highlight items of interest obscured by the generality of ANCO. The first three digits of JANCO represent the ANCO classification.

The JANCO classification system was adopted throughout South Australia's Justice Information System and Courts Administration Authority in 1992 and is managed and administered by the Office of Crime Statistics and Research.

Note: In 1997 the Australian Bureau of Statistics introduced the Australian Standard Offence Classification (ASOC) to replace ANCO - refer Australian Standard Offence Classification, 2008 (Second edition), Catalogue No. 1234.0. These two systems are not directly comparable, with ASOC having sixteen divisions for criminal offences rather than ANCO's eight divisions.

Introductory notes

Background

The JANCO classification system is the JIS (Justice Information System) implementation of the Australian National Classification of Offences (ANCO) that was developed by the Australian Bureau of Statistics (ABS) in 1985. The ABS introduced the Australian Standard Offence Classification (ASOC) in 1997 to replace ANCO, however JANCO offence codes continue to be used in South Australia for State based crime reporting.

ANCO consisted of 9 divisions of offences in a hierarchical structure. The 9 divisions were divided into subdivisions that were further subdivided into groups. At the group level (the finest level of offence detail available in ANCO) ANCO codes consisted of 3 numeric characters.

JANCO codes are based on ANCO codes, but have the following differences:

- JANCO codes may be up to 10 digits in length (allowing more detail than ANCO's 3 digits).
- Division 9 has been expanded from dealing with Child Welfare Matters only to include all Non Offence Matters, such as applications for restraining orders.
- ANCO codes in divisions 1 to 8 have been further expanded to include reporting categories to meet State reporting requirements. For example, ANCO code 136 (Sexual Assault) has been expanded to distinguish different types of Sexual Assault, such as Rape, Indecent Assault, etc and, within those expanded categories, further categories to distinguish by such factors as the age and gender of the victim.

It should be noted that the first digit of each JANCO code identifies the equivalent ANCO division, the first 2 digits represent the ANCO subdivision, and the first 3 digits are the ANCO group code. Hence, in the additional notes within the classification, the terms Division, Subdivision and Group have been used to refer to codes with 1, 2 and 3 digits, respectively.

Applying JANCO codes

When applying a JANCO code, the most detailed code within the hierarchical structure for the appropriate offence category should be used, and these codes have been bolded in the classification listing to aid identification. For example, code 112 should not be applied since the more detailed codes 1121 and 1122 exist.

Each JANCO code has a Start date identifying the first effective date for that code. Note that all effective codes at the initial implementation of JANCO (in 1992) have a start date of 1/1/1901.

Terminated JANCO codes (codes that have been replaced or discontinued) also have an End date identifying the last effective date for that code. Terminated codes are shown in the classification however they are listed using a different font to visually indicate that they are no longer active.

Accessories, aiding and abetting, inciting

Accessory before the fact, aiding and abetting, and inciting the commission of an offence are classified to the relevant lowest level offence category for the substantive offence involved, with the exception of murder for which there are specific groups of 112 for attempted murder and 113 for conspiracy to murder.

Where the offence type is unknown, accessory before the fact, aiding, abetting and inciting are classified to JANCO code 5496.

Accessory after the fact is classified to JANCO code 5496.

Attempted offences

Attempted offences are classified to the relevant lowest level of offence category for the substantive offence, with the exception of murder and some sexual offence categories for which specific JANCO codes have been provided for attempted offences.
